



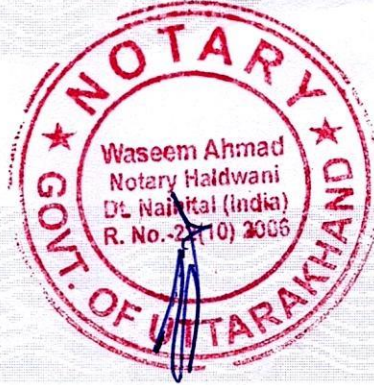

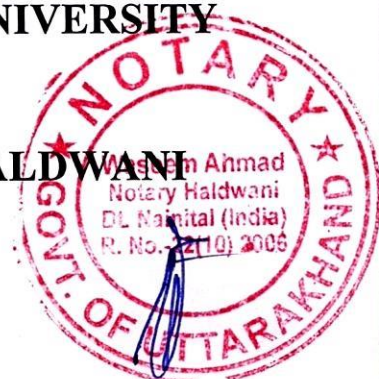

**1. Parties**

The parties to this MEMORENDUM OF UNDERSTANDING are

- Pandit Sundarlal Sharma (Open) University Chhattisgarh, Bilaspur hereafter referred to as "PSSOU."
- Uttarakhand Open University hereafter referred to as "UOU"

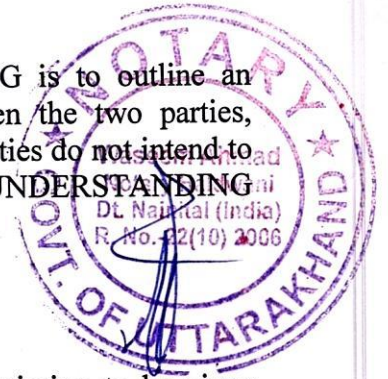
**2. Purpose**

- 2.1 The purpose of this MEMORENDUM OF UNDERSTANDING is to promote scholarly collaboration, cultural interaction and friendship by supporting educational, professional and cultural activities among faculty and students of the two institutions. Accordingly, the areas of cooperation will include, subject to mutual consent, the programmes of study, research studies, models of institutional academic governance, policies, documents, *etc.*, with the core spirit of co-operation for sharing and ensuring the maximum utilizations of scarce resources between the two Universities.
- 2.2 Specific areas of cooperation between the two institutions, subject to the availability of funds and the approval of UOU and PSSOU, will include, but not limited to, the following:
- (a) Exchange of faculty members;
  - (b) Joint research activities including interdisciplinary research and research projects;
  - (c) Developing and executing special academic programmes;
  - (d) Joint consultancies;
  - (e) Organizing joint conferences/seminars/workshops;
  - (f) Exchange of academic materials and other policies and documents;
  - (g) Exchange of resources for academic purpose; and
  - (h) Access of Library and library resources to the Learners of the two academic institutions.
- 2.3 Additional areas of mutual cooperation shall be subject to written consent of both the institutions.

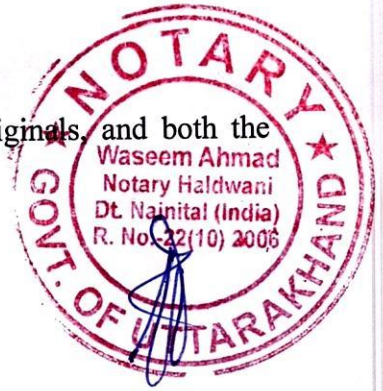
### 6. Other Terms


